INTERNET POLICY (revised 2008)

RATIONALE

Mater Dei Primary School recognises that student and staff access to the Internet is a valuable resource in the location and manipulation of information.

POLICY

- 1. Mater Dei understands its responsibilities for appropriate usage of the internet and E-mail facilities.
- 2. Students access the Internet and use E-mail facilities, under teacher supervision.
- 3. Students will complete a 'Student Internet Access Contract', including parent permission, before accessing the Internet.

OPERATIONAL GUIDELINES

- 1. The Internet is to be used to access appropriate curriculum related materials for classroom and school purposes.
- 2. Students agree to access only those sites that they are willing to share with their parents and teachers.
- 3. If an inappropriate site is accessed accidentally, students will immediately minimise the screen and inform the teacher immediately.
- 4. Students will not give out personal details such as surnames, addresses or phone numbers themselves or others, whilst using the Internet or E-mail.
- 5. Students, who mistakenly access inappropriate material, will tell the teacher immediately. If they fail to do so, it will be assumed that it was intentional and they may lose the privilege of using the internet.

Student Internet Access Contract

Prep - Year 3

- 1. Students will follow teacher instructions regarding the use of the internet.
- 2. Students will remember that it is a privilege, not a right, to use the internet.
- 3. Students, when using the internet or email:
- Will only access or send information which is relevant to his/her work and he/she is willing to share with parents and teachers.
- Will respect the privacy of their family, their fellow students and themselves by not giving out any personal details such as surnames, addresses or phone numbers of themselves or others, whilst using the Internet or E-mail.
- Will not send or access junk mail or inappropriate material. Should they
- receive any, they will inform the teacher immediately.
- Will, when finding inappropriate material on the internet or in an email,
- minimise the screen and inform the teacher immediately.
- 4. Students, who mistakenly access inappropriate material, will tell the teacher immediately. If they fail to do so, it will be assumed that it was intentional and they may lose the privilege of using the internet.
